The purpose of this initiative is to enhance campus safety by installing an Automated External Defibrillator (AED) in the AG/Shop building. At present, the nearest AED is located in the cafeteria, which is a separate building. Students in the AG/Shop regularly engage in activities that involve welding, electrical work, and the operation of heavy equipment—tasks that inherently carry an elevated risk of medical emergencies, including potential cardiac events.

The placement of an AED in this building will significantly reduce emergency response time and provide immediate access to life-saving equipment. This proactive measure supports the district's commitment to student and staff safety and aligns with best practices for emergency preparedness in high-risk instructional areas.

The primary goal of this initiative is to strengthen campus safety and emergency preparedness by ensuring immediate access to life-saving equipment in the AG/Shop building. Installing an Automated External Defibrillator (AED) directly aligns with the district's mission to provide a safe, supportive, and responsive learning environment for all students.

Specific Objectives:

Enhance emergency response capabilities by reducing the time required to access an AED during a cardiac event.

Protect the health and safety of students and staff engaged in high-risk activities such as welding and

operating electrical or mechanical equipment.

Support staff readiness by integrating the AED location into existing emergency response protocols and

ensuring personnel are trained in its use.

Promote a culture of safety and preparedness that enables uninterrupted, secure learning environments.

This initiative reinforces the district's commitment to safeguarding student well-being and ensuring that safety measures are in place to support all educational programs, including career and technical education.

The estimated cost for this project is \$1,800–\$2,200. This includes the purchase of one ZOLL AED Plus, which is the preferred model currently used throughout the district to ensure consistency and compatibility with existing training and maintenance procedures. AED Unit: \$1,700–\$2,000 Wall-Mounted Safety Cabinet: \$100–\$200 Standardizing AED equipment across the district allows staff to utilize existing training resources and ensures streamlined maintenance and inspection processes.

The primary beneficiaries of this initiative are students and staff who utilize the AG/Shop building for Career and Technical Education courses, including welding and other hands-on technical programs. The installation of an Automated External Defibrillator (AED) in the AG/Shop building is expected to significantly enhance the overall safety and well-being of students and staff. By ensuring immediate access to life-saving equipment, the district can reduce emergency response times and improve outcomes in the event of a cardiac emergency.

We will have regular monitoring of the AED unit to ensure functionality, proper maintenance, and compliance with district safety requirements.

This proactive measure reflects the district's commitment to maintaining a safe and prepared learning environment.
