

Dear Parents,

The Elementary Health and Physical Education Department has developed a scope and sequence that includes a lifetime sports curriculum. We feel that a broad spectrum of learning opportunities should be offered to develop an interest in as many health, wellness, and fitness activities as possible. Our goal is to enable each student an opportunity in acquiring a well-rounded assortment of activities.

To help us meet this goal, we are planning a ski trip at Magic Mountain Ski Resort. This trip is planned for **Thursday, February 6th** for Mrs. Harmon's class. We would like to invite you to attend this field trip with your child. This opportunity is only for parents/guardians, no brothers, sisters, cousins, aunts, uncles, etc. If others attend, they will pay the normal lift ticket cost. **If you are planning to go on this field trip you will need a volunteer form and background check before you can go. If you have already filled one out, you are good for 5 years.**

The cost to each student/parent for this one-day, one-time field trip will be \$27.00 if renting skis or snowboard. If you intend to bring your own equipment the fee is \$22.00. This fee includes a ski school lesson (required for all students), all-day lift privileges, and ski rental equipment (skis, boots, and/or snowboard and boots). There will be an option to rent a helmet. They are encouraged and are \$5.00 extra. Mark on your rental form if a helmet is needed. The bus will leave Kimberly Elementary at 8:30 a.m. and return to the school between 4:00-4:15 p.m. Parents are responsible to pick their student up from school. An insurance waiver, rental form and students' fees need to be returned to classroom teacher no later than **Monday, February 3rd**. Only student fees are due to the school prior to the trip. **Parents will pay their fee at the lodge on the day of the trip and get their ticket from the lodge.** Parents need to drive their own vehicles to Magic Mountain Ski Resort as there are only enough seats on the bus for students and teachers. **Parents, please try to be at least 45 minutes ahead of the school to allow time to pay and get fitted before students do.** Students may ride home with THEIR OWN parents but must ride the bus up to the mountain. **Students must be signed out from classroom teacher to ride home with parents. There is an option if a student wants to go home with a friends' parent but will need to have that parent and their own parent sign the alternate transportation agreement on the website, under the parents' section. This need to be filled out 24 hours before the ski trip day.**

If you write a check, please make it payable to: **Kimberly Elementary School.**

Lunch options for the day: students purchase at the lodge, sack lunch from home or prepared by the school to take up. Please mark on your form if a school lunch needs to be provided.

We would like to encourage all students to attend the field trip. If for some reason you feel your child should not go, there will be planned school activities for those students who will not be participating in the ski field trip. This will be a regular school day and attendance will be taken as normally done each day. We feel that this is a very enriching learning experience that could possibly carry over into a lifetime fitness activity.

If you have already filled one out, you are good for 5 years.**

The cost to each student/parent for this one-day, one-time field trip will be \$27.00 if renting skis or snowboard. If you intend to bring your own equipment the fee is \$22.00. This fee includes a ski school lesson (required for all students), all-day lift privileges, and ski rental equipment (skis, boots, and/or snowboard and boots). There will be an option to rent a helmet. They are encouraged and are \$5.00 extra. Mark on your rental form if a helmet is needed. The bus will leave Kimberly Elementary at 8:30 a.m. and return to the school between 4:00-4:15 p.m. Parents are responsible to pick their student up from school. An insurance waiver, rental form and students' fees need to be returned to classroom teacher no later than **Monday, February 3rd**. Only student fees are due to the school prior to the trip. **Parents will pay their fee at the lodge on the day of the trip and get their ticket from the lodge.** Parents need to drive their own vehicles to Magic Mountain Ski Resort as there are only enough seats on the bus for students and teachers. **Parents, please try to be at least 45 minutes ahead of the school to allow time to pay and get fitted before students do.** Students may ride home with THEIR OWN parents but must ride the bus up to the mountain. **Students must be signed out from classroom teacher to ride home with parents. There is an option if a student wants to go home with a friends' parent but will need to have that parent and their own parent sign the alternate transportation agreement on the website, under the parents' section. RENTAL AGREEMENT & RELEASE FROM LIABILITY

1. I accept for use **AS IS** the equipment listed on this form and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full retail value of any equipment rented under this form, but not returned to the rental shop.
2. I have received instructions on the use of my equipment and fully understand its use and function.
3. I have made no misrepresentation to the ski shop about my height, weight, age or ability. This information is required to properly adjust the ski-boot-binding settings.
4. I verify that the binding settings recorded on the front of this form match the numbers appearing in the visual identification windows of the equipment listed on this form.
5. **I understand that the binding system cannot guarantee the user's safety.** In downhill skiing, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release, and it is therefore, no guarantee of my safety. In snowboarding, cross-country skiing and snowshoeing use, the binding system will not ordinarily release during use; these bindings are not designed to release because of forces generated during ordinary operation.
6. I hereby release from any legal liability, Magic Mountain LLC and Magic Mountain Resort Lease LLC, the Rental Shop and its owners, agents, employees and volunteers as well as the equipment manufacturers and distributors of this equipment from any and all liability for injury, death, property loss and damage to myself or to any person or property resulting from the selection, installation, maintenance, adjustment or use of this equipment and for any claim based upon neglect, breach of warranty, contract or other legal theory, accepting myself the full responsibility for any and all such damages, injury or death which may result.
7. **If I am renting a helmet for my child, I understand that helmets cannot protect the user from all types of impacts or injuries that may prevent injury or death.**
8. I understand that injuries are a common and ordinary occurrence of the sport(s) and I freely and voluntarily assume those risks. I understand that me or my child's participation in a lesson or the snow sport may require the use of ski lifts and that my child may ride lifts alone, with another adult or with other children and the use of lifts by my child involves the risk of injury or death.
9. I understand that there are inherent and other risks involved in the sport of snow skiing, boarding and other snow sports. These may involve inherent risks of property damage and/or personal injury to me or others. Such risks may arise from natural or manmade hazards, known and unknown which may exist. By my signature I acknowledge and assume all such risks and hazards and execute the release as to all such risks and hazards **EVEN AS TO SUCH RISKS AND HAZARDS AS MAY BE THE RESULT OF THE NEGLIGENCE OR RECKLESSNESS OF MAGIC MOUNTAIN LLC ITS OWNERS, AGENTS, EMPLOYEES AND VOLUNTEERS, AND TO FOREVER WAIVE ANY AND ALL CLAIMS, CAUSES OF ACTION, CHARGES, DAMAGES, AND DEMANDS OF ANY KIND, INCLUDING FOR INJURIES I RECEIVE AS A RESULT OF MAGIC MOUNTAIN'S NEGLIGENCE. MAGIC MOUNTAIN SCHOOL PROGRAM INFORMATION

Magic Mountain Snowsports is excited to have the opportunity to spend time with your students this season! Our primary goal is to provide a positive learning experience for all who participate! There are inherent risks involved in snow sports, however by knowing what is expected, you can reduce these risks.

PRE-VISIT:

- Review and completely fill out waiver forms.
- Basic exercises greatly enhance student experience on the mountain.
 - ie Standing from sitting position, basic balance, cardio (walking) etc.

How to Dress for Winter Snow Sports: If you cannot acquire these clothes, please let your teacher know.

Outer Clothing:

- Winter Coat
- Waterproof pants
- Warm Gloves/Mittens (water/wind resistant. Knit items retain moisture and get extremely cold.)
- Hat or Ski Helmet (Helmets are available for rent, \$5)
- Sunglasses or Goggles if weather dictates need. (Goggles are available to rent on a limited basis.)

Inner Layers: Dressing in layers allows the student to adjust to changing weather conditions. It is best to have synthetic and not cotton material.)

- Turtleneck / Neck gator
- Sweater or Fleece Jacket or Vest
- Long Johns or Synthetic pants
- 1 pair of socks that come up to mid-calf or knee socks (not cotton).

Other

- Sunscreen
- Lunch or Lunch Money

POSITIVITY! This is dependent upon everyone contributing in a positive manner! We aim to provide a fun, but safety-oriented learning environment and depend on you doing your part!

Student Expectations:

- Come with a can-do attitude!
- Be able to get yourself up after a fall.
- Ski Lift. All students will be tested before being allowed on the chairlift. Student must exhibit proficiency in skills before being allowed to do so. Many do not achieve this on first visit. Safety!
- Be respectful of instructors, other students, employees and guests.
- Disruptive students will be taken to a school official.

Rules on the Slopes and in the Lodge:

- Keep space between you, other people and objects. **KNOW THE CODE!**
- Look uphill and make sure no one is coming before starting downhill. People ahead of you have the right away. YOU must be able to avoid them and objects. Stop where you can be seen and out of the way if possible.
- Observe all posted signs and warnings. Keep out of closed areas and stay in the area boundary.
- DO NOT use a Snowboard as a sled. Ever. If you cannot ride down, be sure your leash is attached to you (arm) and carry your board as you walk down.
- **Be a friend.** Do not encourage friends who are not as skilled as you to go to areas beyond their skill level.
- **DO NOT SKI/BOARD ACROSS THE ROAD!** Use **ONLY YOUR EQUIPMENT** You must return to rental shop at the end of the day to avoid restock charges.
- Please respect others and keep lodge area neat. Clean up your own trash please!

Our goal is providing a fun and safe environment to introduce non-skiing/boarding students to the sport, but also help others improve their skills. Learn while having fun! Remember...positive attitude is key! These are wholesome, lifetime sport activities, and we are fortunate to have our beautiful South Hills so close!

NOTE: 5th and 6th grade Ski Idaho passports are not eligible during school/group visits.
